- 2. The receiving institution will send its decision within the following time frame:
- **G PIREASO1:** Nominated students receive by e-mail their Application Form and Learning Agreement that they have to complete within the deadline above. Once completed, they receive an acceptance letter by e-mail within a max. of 6 weeks. Changes To Original Learning Agreement can only be made by students in the 2 weeks after the start of classes. Must respect this deadline.

TR ANKARA 03: Nominated students receive by e-mail their Application Form and Learning Agreement that they have to complete within the deadline above. Once completed, they receive an acceptance letter by e-mail within a max. of 6 weeks. Changes To Original Learning Agreement can only be made by students in the 4 weeks after the start of classes.

- 3. **G PIREASO1**: A Transcript of Records will be issued by the receiving institution no later than **5** weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
- TR ANKARA 03: : A Transcript of Records will be issued by the receiving institution no later than **6** weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
- 4. Termination of the agreement

This agreement will be in effect for the full duration of the ERASMUS+ Programme. In case of premature termination, a notice of at least one academic year will be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
